- 2. Brush apply a light coat of **BEAD SEALER** on the outside of the bead sealing area of the tire. Avoid puddling or bubbling.
- 3. Re-inflate the tire and carefully check for leaks. If needed, apply a second coat of **BEAD SEALER** to the tire/rim sealing area.
