

Install the base inserts in the holes as shown.

Push the cut end of the cord through one of the "P" clamps.

Splice the power wires from the strobe to the cut end of the

adapter cord, using the butt connectors provided (Red to Black and Black to Black with white lettering). Loop the power wires through the remaining "P" clamp as shown, and using the supplied 10-32 x $\frac{1}{2}$ " screws, fasten the clamps to the base.

Mount the vacuum-magnet unit to the bottom of the strobe base, using the #8 Plastite screws and washers. Start the screws w/washers down through the mounting holes in the base, and thread into the vacuum-magnet unit. Make sure you line up the notch in the unit with the notch in the strobe

WARNING!

Maximum recommended vehicle speed for safe operation using the Vacuum Mount model is 65 mph (104 km/h), when fitted to the center of a vehicle roof of steel construction. Higher speeds could cause the mount to fail, resulting in the beacon flying off of the vehicle, which could cause damage to other vehicles, and injury or death to the passengers.

The Vacuum Mount is not intended as a permanent mounting for the beacon. Metallic debris collected by the Vacuum Mount will contribute to rust stains. Ensure that the Vacuum Mount is kept clean.



Mounting:

To remove unit from vehicle, lift each tab to release the airlock (See Figure 2). To protect the rubber cushion/magnet assembly, return warning light to the box when not in use. **Do not attempt to attach to ice covered surface.**



For proper operation, verify lighter/auxillary outlet circuit is rated to supply, a minimum of 10 amps. (See specifications section for rated current in amperes). Do not exceed the current rating for the lighter power outlet recommended by vehicle manufacturer.

Keep lighter adapter, and outlet, clean and free of debris.

Do not use the lighter adapter when wet.

Insert lighter adapter fully into the outlet for proper connection.

Grasp lighter adapter, NOT cord, to remove from outlet.

Remove lighter adapter completely from outlet when light is not in use.
